The programs have been granted accreditation for 3 years. **Government Engineering College, Sreekrishnapuram, Mannampatta.(P.O), Palakkad-(Dt), Kerala-678633** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a visit, as deemed appropriate by NBA Committees.
